(ii) MEDICAL NEGLIGENCE - BONE GRAFTING OPERATION - Leaving pieces of gauze inside-Wound did not heal for long-Award of compensation of Rs. 10,000/- without considering documents produced by the patient- Matters sent back to the District Forum for deciding it afresh. (Paras 2 & 3)


